### Bridges Children & Young People - Referral Pathway now open

Following a temporary pause to referrals for Children and Young People experiencing Domestic Abuse, Bridges are pleased to announce the referral pathway is now **open** and can be accessed via the [Bridges Partnership - Children & Young People – Fill in form](#)

**Please note:** They are unable to accept referrals in any other format.

The new referral form should be used for **all referrals for CYP across the partnership**, including:

1. **Young Person's Domestic Abuse Support**  
Delivered by accredited YPVAs for young people aged **13–17 years** who are experiencing or at risk of abuse within their own intimate relationships.
2. **Domestic Abuse Recovery Support**  
Delivered by accredited CHIDVAs for children and young people aged **6–17 years** impacted by domestic abuse occurring between other members of the household.
3. **RESPECT Programme**  
Support for children and young people aged **10+** who are displaying harmful behaviours towards parents and carers.
4. **Encouraging Healthy Relationships Programme**  
Support for children and young people aged **10+** who are displaying harmful and unhealthy behaviours towards intimate partners, ex-partners, or siblings.

Upon submission of your referral, you will receive an **automatic acknowledgement** detailing the next steps.

## Solihull Approach Training

The Solihull Approach promotes emotional health and well-being for children and families through evidence-based resources and training. Widely adopted across the UK, it supports workforce development, early intervention, and team building. Parenting programmes are available from conception to adolescence, both face-to-face and online in 108 languages, with a strong emphasis on including fathers.

With over 35 research publications and positive outcomes, such as reduced teacher stress and improved efficacy, the Solihull Approach is recognised by the Department of Health, NICE, and the Early Intervention Foundation.

## Graded Care Profile 2 (GCP2) – TSCP Training

### Why this matters:

Neglect affects 1 in 10 children in Tameside, making it one of our most pressing safeguarding priorities. The Graded Care Profile 2 (GCP2) tool is central to our commitment to help professionals understand what life is really like for a child and take effective action.

### What is GCP2?

GCP2 is a strength-based, evidence-informed assessment tool that measures the quality of care a parent or carer provides in meeting their child's needs. It supports professionals to identify areas of concern and strengths, enabling timely and targeted interventions.

### What you'll gain from this training:

- Hands-on experience: Learn how the tool works and complete a full assessment.
- Accreditation: Receive a GCP2 license to use the tool in your practice.
- Resources: Access all training materials for ongoing support.
- Impactful practice: Gain confidence to provide guidance, interventions, or make referrals to the right agencies.

### Why this training matters:

The local authority has a statutory duty to offer all children and young people who run away or are reported missing a Return Home Interview. These interviews are vital to understanding why a child went missing and how to reduce future risk.

### The risks of going missing:

Children and young people who go missing are at increased risk of:

- Abuse in any form
- Substance misuse
- Poor mental health
- Disrupted education and relationships
- Reduced life chances

### They are also particularly vulnerable to:

- Trafficking
- Violent crime
- Drug use
- Exploitation, including sexual and criminal exploitation

### Who should attend?

Carers and professionals who want to develop knowledge and understanding of missing episodes and learn how to respond effectively.

## Free Asthma Awareness Training – Still Available

Do you work with children or young people in a childcare, clinical, or non-clinical setting?

Enhance your confidence and knowledge with **FREE online NHS training**, designed to help you safely care for children and young people with asthma.

Did you know that around **1 in 11 children** in the UK have asthma—approximately **1.1 million children**? Each year, over **60,000 children** are admitted to hospital due to asthma attacks. The latest data from the child mortality database 2024, found that, sadly 54 children died from asthma.

Many of these deaths are preventable with the right care and awareness. The [\*\*Tier 1 Asthma Awareness Training\*\*](#) takes just **45 minutes** to complete and provides essential skills and knowledge to help you make a difference.

**The Brook Sexual Behaviours Traffic Light Tool** is a tool to identify, understand and respond to sexual behaviours in children and young people up to 18 years old.

Curiosity about bodies and sex is a normal part of development. However, some sexual behaviours can be a sign of abuse or CSE (Child Sexual Exploitation). Brook's tool can help you know the difference.

This tool was originally introduced in Tameside following a serious case review. It takes up to 2 hours to complete. TSCP still has plenty of licences available for all partners to access.

### Violence against women and girls

## NSPCC Learning

The UK government has published its strategy addressing violence against women and girls. The strategy outlines the work the government is committed to undertaking, based on three areas: prevention and early intervention; working to improve justice outcomes; and support for those affected by violence and abuse. The strategy includes a section on child sexual abuse covering the government's response to the Independent Inquiry into Child Sexual Abuse (IICSA); reforms introduced by the Online Safety Act and Crime and Policing Bill; and

group-based child sexual exploitation and abuse. The strategy is UK-wide but specific commitments on crime, policing, and justice apply to England and Wales, while those on health, social care, housing, transport, and education apply to England only. An action plan and an evidence summary on effective approaches to reducing violence against women and girls have also been published.

It also highlights pending legislation: The Children's Wellbeing and Schools Bill and brings to the attention of readers Ofsted and Care Quality Commission (CQC) Thematic Reviews of Children Not in School in Local Areas, which were undertaken in 2025.
